- Applicants ages 18 and up must show proof of current address AND photo ID. To access your account online, you will be assigned a library card number and a 4-digit PIN (the last 4 digits of your card number). You may use your library card at any Barry-Lawrence Regional Library location. You will be responsible for damages or loss of materials on this card and must follow library use policies.
- Applicants ages 6 -17 must have a parent or guardian accept responsibility for your card. Parent or guardian must agree to the required statements below per 15 CSR 30-200.015 Library Certification Requirement for the Protection of Minors subsection (c). If parent or guardian does not agree, applicants ages 6-17 will not be issued a card.
- Your card is good for one year.
- A fee is charged for card replacement
